### **ADMINISTRATIVE GUIDE**

## **ENTITLEMENT TO PARTICIPATE AND VOTE**

Only members whose names appear in the Record of Depositors and/or Register of Members as at 22 August 2024 will be entitled to participate and vote remotely at the 40<sup>th</sup> AGM or appoint a proxy/proxies to participate on his/her behalf.

## **REMOTE PARTICIPATION AND VOTING ("RPV")**

Members are entitled to participate (including posing questions to the Board via real time submission of typed texts) and vote remotely at the 40<sup>th</sup> AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

A member who has appointed a proxy or authorised representative to participate and vote at the 40<sup>th</sup> AGM via the RPV must request his/her proxy or authorised representative to register himself/herself for the RPV at TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

As the 40<sup>th</sup> AGM is a virtual AGM, members who are unable to participate in the AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Form of Proxy.

## PROCEDURES FOR RPV

Members/proxies/corporate representatives who wish to participate in the 40<sup>th</sup> AGM remotely via RPV are to follow the requirements and procedures as summarised below:

Member(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 40<sup>th</sup> AGM to ascertain their eligibility to participate in the 40<sup>th</sup> AGM using the RPV.</li> <li>Login with your user ID and password and select the corporate event: "(REGISTRATION) IJM 40<sup>TH</sup> AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select "Register for Remote Participation and Voting".</li> <li>Review your registration and proceed to register.</li> <li>Tricor will send an e-mail to notify that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the General Meeting Record of Depositors as at 22 August 2024, Tricor will send you an e-mail on 28 August 2024 to approve your registration for remote participation.</li> <li>(Note: Please ensure to allow sufficient time required for the approval as a new user of TIIH Online as well as the registration for RPV to facilitate your login to TIIH Online and participate in the 40<sup>th</sup> AGM remotely).</li> </ul>

(c)	Login to TIIH Online	<ul> <li>Login with your user ID and password for remote participation at the 40<sup>th</sup> AGM at any time from 9.00 a.m. i.e. one (1) hour before the commencement of the 40<sup>th</sup> AGM at 10.00 a.m. on Thursday, 29 August 2024.</li> </ul>				
(d)	Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) IJM 40<sup>TH</sup> AGM" to engage in the proceedings of the 40<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairman and/or the Board, you may use the query box to transmit your question. The Chairman and/or the Board will endeavor to respond to questions submitted by remote participants during the 40<sup>th</sup> AGM. If there is time constraint, the responses will be emailed to you and/or provided on our website.</li> </ul>				
(e)	Online Remote Voting	<ul> <li>Voting session commences from 10.00 a.m. on Thursday, 29 August 2024 until a time when the Chairman announces the completion of the voting session of the 40<sup>th</sup> AGM.</li> <li>Select the corporate event: "(REMOTE VOTING) IJM 40<sup>th</sup> AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>				
(f)	End of remote Participation	Upon the announcement by the Chairman on the closure of the 40 <sup>th</sup> AGM, the live streaming will end.				

### Note to users of the RPV facilities:

- 1. Should your registration for RPV be approved, Tricor will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.
- 3. Register as a User with TIIH Online	<ul> <li>Access TIIH Online at <a href="https://tiih.online">https://tiih.online</a></li> <li>Under e-Services, the authorised or nominated representative of the corporate shareholder selects "Create Account by Representative of Corporate Holder".</li> <li>Complete the registration form and upload the required documents.</li> <li>Registration will be verified, and you will be notified by e-mail within one (1) to two (2) working days.</li> <li>Proceed to activate your account with the temporary password given in the e-mail and re-set your own password.</li> <li>Note: The representative of a corporate shareholder must register as a user in accordance with the above steps before submission of proxy form. Please contact our Share Registrar if you need clarifications on the user registration.</li> </ul>

Upon completion of the voting session, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
